INTENT TO COMPETE FORM – TERMS AND CONDITIONS FOR ATHLETES

1. Declaration
I wish to compete for the Guernsey Commonwealth Games Association LBG at the 2022 Commonwealth Games to be held in Birmingham, England between 28 July and 8 August 2022, and agree to sign the Team Agreement if selected to Team Guernsey for the 2022 Games.
2. Data Protection and GCGA Privacy Policy
I have read the GCGA Privacy Policy and understand its contents. I give my permission to the GCGA to share my personal details for the sole purpose of the Commonwealth Games.
3. Travel
I understand that full travel and immediate pre-Games preparation time required to attend the Games could reach three weeks. Furthermore, if required by the GCGA for best practice purposes for the Team I will surrender my accreditation pass to the Team Management and depart the Games once my competition has ended or if I become ill or injured.
4. Eligibility
I am eligible to compete for Guernsey at the Commonwealth Games, and comply with the GCGA and the CGF entry and eligibility Rules, which are detailed on Form 1. I also fulfil the eligibility rules of my International Sport Federation.
5. Meetings/Events
I will supply any information needed, attend any meetings in connection with the Team selection process and participate fully in all pre-Games meetings and events staged by the GCGA.
6. Medical Fitness
I will advise my Sport Manager/Official and the Secretary of the GCGA if I am not medically fit to travel or compete at the Games, and will, if requested by the Directors of the GCGA, submit to a review of my medical fitness and form. I acknowledge that once selected, if my medical or physical condition or form are considered to be below the level required to compete at the Games, and particularly if below the level I achieved to be considered for selection, that I may be deselected in accordance with the Team Agreement.
7. Injury or Illness
I understand that should I become ill or injured whilst at the Games I will, if requested by the Directors of the GCGA or Team Management, surrender my accreditation pass to the Team Management and depart the Games.
8. Benefits and Expenses
I will provide the Secretary of the GCGA with any information relating to benefits and expenses that I may receive from the GCGA, the Commonwealth Games Federation, and the Games Organising Committee. This includes providing competition and training plans, together with pre-event budget costs and receipts. I agree to pay all expenses relating to the Games that are not covered by the GCGA.
9. Administration
I agree to complete all information requested of me, whether on paper or via the internet, and understand that should I fail to meet deadline dates provided to me I may not be selected for the Games. I further agree that my personal details may be shared by the GCGA with the CGF and Games Organising Committee for the sole purpose of the Games.
10. Qualifying Criteria
I agree to the qualifying criteria agreed between my sport and the GCGA Council and understand that achieving my sport qualifying criteria does not provide me with automatic selection to Team Guernsey for the Games. I understand that the deadline qualifying criteria date is 31 December 2021.
11. Personal Coaches
I understand that personal coaches are not permitted to receive Games Accreditation to reside in the Games Village or access the Field of Play during competition time. Athletes may apply, through their sport, to the GCGA for personal coaches to receive Games Accreditation, within the rules provided by the CGF or Games Organising Committee, but they shall not be part of the official Team Guernsey and any costs will be borne by the athlete or my sport.
